It contains a set of ten personal stories with graphics drawn by Sylvie, a daughter of one of Sympathea's members. Sylvie suffers from paranoid schizophrenia and had newly her own exhibition of pictures together with two other persons affected by mental illness. The book also explains what parents should know, the legislation and how it should be respected and gives advice on how to get a subsidy for social service.

### Malta Mental Health Association - Empowering Caregivers Course 2013

MHA is organising their 20 hour annual Empowering Course which will attempt to help participants understand mental illness and work on skills like problem-solving, communication skills and crisis management, that help the person affected recover a better quality of life. This course is intended for family members, all those working or planning to work in the mental health sector like psychiatric nurses, psychologist, social workers, counsellors, educators, community health workers, NGO staff and volunteers.



### FRA publishes report on inequalities and multiple discrimination in access to healthcare

The European Union Agency for Fundamental Rights (FRA) has published a new [report on "Inequalities and multiple discrimination in access to and quality of healthcare"](#). The report looks at some of the practical barriers and experiences of unequal treatment in accessing healthcare that people may face because of a combination of their traits for example, ethnic origin, gender, age and disability. The report looks at how 'multiple' discrimination is legally addressed and examines relevant case law with a special focus on healthcare.
